Director Whitlock OMMS contracted with an outside agency to review the financial practices of OACP specifically regarding cash receipts, cash disbursements, and bank reconciliations completed by OMAG on behalf of OACP. During this review, no findings were noted. Staff would request that the Board acknowledge the report as prepared.

Director Whitlock advised that there was a \$60 increase on the conference that would raise the cost from \$399 to \$460.

8. Update on the 2024 Legislative Session.

Director Whitlock said bills were moving through the process, 4500 bills filed staff is tracking 500 bills.

Chief Younger SB1967 Firearms theft a felony.

SB1970 Increasing penalties for eluding.

SB1596 SRO Guardian Certification

Senate Public Safety Committee has a standing meeting every Thursday at two o'clock.

Chief Cluck Chief Qualification bill not moving through due to a concern of what would happen in small departments.

Chief Kidney spoke about going to the capitol over SB 1596 Missing Child. Asking that the language shall contact OHP to may. Met with Senator Thompson and had a positive meeting. Present was Chief Sweger and Chief Burns.

9. Update on the Oklahoma Law Enforcement Accreditation Program.

Kevin McCullough stated OLEAP has been working on President Biden's Executive Order No. 14074, which contains 21 standards that police departments are required to meet.

10. Update from the Council on Law Enforcement Education and Training.

Director Stacy said staff had been working with the department of mental health in order to streamline the process to obtain approved mental health lesson plans. The mandatory online trainings missing persons and sexual assault with have a mental health hours added to them. CLEET Graduation will be February 22nd at 3 p.m.

11. Executive Director's Report.

Director Whitlock reminded everyone of the dates of the 2024 Conference, which is May 20th-24th in Durant. He also mentioned that awards nominations are due by March 1st.

12. President's Report.

Chief Sweger stated that Chief Kidney's legislative breakfast had a good turnout by the board. He also encouraged everyone to encourage their Senator or Representative to attend next year.
